## **THE BUILDERS EXCHANGE OF ROCHESTER END USER LICENSE AGREEMENT**

Your use of the Plans Online Service constitutes your agreement to the following terms and conditions and rules and regulations that may be promulgated from time to time. If you do not agree to be legally bound the Builders Exchange of Rochester will not permit you to use or access the Plans Online Service.

The Plans Online Service is provided AS IS AND WITHOUT WARRANTY. In no event shall the Builders Exchange of Rochester or its suppliers be liable for any special, indirect, or consequential damages of any nature resulting from the use or operation of the Plans Online Service or any information in the Plans Online Service.

1. **Grant of License.** The Builders Exchange of Rochester grants to Licensee, and Licensee accepts, a non-exclusive, non-transferable license, to use for only Licensee's business purposes, the information in the Plans Online Service, this website, the software and related documentation (collectively and individually referred to as "Plans Online Service"). The license shall only be effective while Licensee is a member in good standing of the Builders Exchange of Rochester. This license may be renewed from year to year upon payment of the annual membership fee and continued compliance with the terms of The Builders Exchange of Rochester End User License Agreement ("Agreement"). **Licensee may only use the Plans Online Service on its own behalf by direct employees of licensee** . The sharing of any user name and/or password is strictly prohibited and shall be grounds for immediate termination of this Agreement or the **imposition of additional fees in the amount of two times the annual membership fee for each unauthorized use of the Plans Online Service**, in the sole discretion of The Builders Exchange of Rochester. Use of the Plans Online Service is for estimating purposes only; copying is prohibited.

Except for the license rights mentioned in this Paragraph, no right, title or interest in the Plans Online Service is granted to Licensee. Licensee will not itself, or through any parent, subsidiary, affiliate, agent, or other third party ("Related Entities") reproduce, distribute, modify, translate, decompile, disassemble, reverse engineer or transmit in any form or by any means any part of the Plans Online Service. Further Licensee and/or Related Entities will not sell, lease, license, sublicense, or market the Plans Online Service.

2. **Proprietary Rights.** Licensee acknowledges that the Plans Online Service is confidential and contains trade secret information that is the exclusive property of the Builders Exchange of Rochester.

3. **Payment.** Licensee agrees to pay the initial Plans Online subscription fee and any applicable annual membership fees. The initial subscription fee includes the first year fee for the Plans Online Service. Annual subscription fees after the first year will be invoiced and are due prior to the commencement of the applicable subscription fee period. The Builders Exchange of Rochester has the right to adjust subscription fees.

4. **Plans Online Service.** The Plans Online Service contains information about plans, bidders and other matters that may be of interest to members of the Builders Exchange of Rochester. Information reported in the project files is based on a review of the specifications; no plans have been reviewed. Efforts have been made to assure the accuracy of the information reported, but the Builders Exchange of Rochester provides no warranty, expressed or implied, that any of the information is accurate. The actual plans and specifications that are maintained at the Builders Exchange of Rochester are the best source of information for project files.

5. **Copyright Laws.** The United States Copyright laws prohibit the distribution or copying of copyrighted works without proper authorization. The Builders Exchange of Rochester will not tolerate any use of the Plans Online Service that in any way violates the United States Copyright laws. Licensee must report to the Builders Exchange of Rochester editor any use of the Plans Online Service that may constitute copyright infringement. If the Builders Exchange of Rochester, in its sole discretion, determines that any material has been added to the Plans Online Service in violation of the copyright laws, the Builders Exchange of Rochester will delete that material. Anyone who adds unlawful material to the Plans Online Service shall indemnify, defend and hold the Builders Exchange of Rochester harmless from any and all resulting claims and/or liability (including the payment of litigation costs and attorney fees).

6. **Limitation of Liability.** Licensee agrees that the Builders Exchange of Rochester is not an insurer and shall have no liability arising out of the use or operation of the Plans Online Service and/or any information generated thereby. In no event shall the Builders Exchange of Rochester's total liability for any claim arising out of or under this Agreement, or the use and/or operation of the Plans Online Service, regardless of the cause of action, exceed the annual membership fee.

7. **NO CONSEQUENTIAL DAMAGES.** IN NO EVENT SHALL THE BUILDERS EXCHANGE OF ROCHESTER BE LIABLE FOR ANY SPECIAL, INDIRECT OR CONSEQUENTIAL DAMAGES, INCLUDING, BUT NOT LIMITED TO, LOSS OF REVENUES AND LOSS OF PROFITS, EVEN IF THE BUILDERS EXCHANGE OF ROCHESTER HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

8. **Indemnity.** Licensee agrees to indemnify, defend and hold harmless the Builders Exchange of Rochester, its officers, directors, employees, and agents from any damages, losses, costs or expenses (including the payment of litigation costs and attorney fees) that arise from Licensee's use and/or operation of the Plans Online Service.

9. **Warranty.** Licensee agrees that the Plans Online Service is provided as is and without warranty and that the Builders Exchange of Rochester makes no representations regarding the completeness or accuracy of the Plans Online Service or any information provided by the Plans Online Service. The Builders Exchange of Rochester expressly disclaims any implied warranties of merchantability or fitness for a particular purpose.

10. **Access.** The Builders Exchange of Rochester reserves the right to control and/or limit access to the Plans Online Service in its sole discretion. Access may be denied at any time. Access may be denied to any individual who makes use of the Plans Online Service for an inappropriate purpose, in violation of this Agreement, or who, in the sole discretion of the Builders Exchange of Rochester, uses inappropriate, obscene, abrasive, or otherwise questionable language in connection with the Plans Online Service.

11. **Content Control.** The Builders Exchange of Rochester reserves the right to monitor in its sole discretion all information contained in or used in connection with the Plans Online Service and to delete or edit any file, program or message that contains inappropriate, obscene, abrasive or otherwise questionable language. However, the Builders Exchange of Rochester is not required to monitor the information.

12. **Governing Law.** This Agreement shall be governed by the laws of the State of Minnesota without regard to choice of law rules. The United Nations Convention on the International Sale of Goods shall not apply.

13. **Export Controls.** Licensee agrees and certifies that neither the Plans Online Service, nor any other technical data received from the Builders Exchange of Rochester, nor the direct product thereof, will be exported or re-exported outside the United States except as authorized and as permitted by the laws and regulations of the United States.

14. **Assignment.** This Agreement may not be assigned by Licensee without the express written permission of the Builders Exchange of Rochester.

15. **Termination.** The Builders Exchange of Rochester reserves the right to terminate Licensee's rights to use the Plans Online Service at any time if Licensee violates the terms of this Agreement. Either Licensor or Licensee may terminate this Agreement without cause. Upon termination of this Agreement Licensee shall cease all use of the Plans Online Service and shall destroy all user names and/or passwords.
